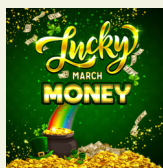

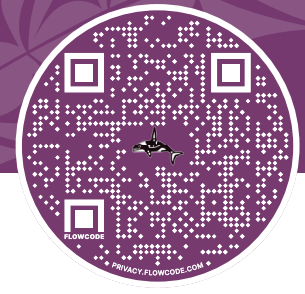

NOVEMBER 2021

Public Safety

Marysville Fire District Monthly Report:

- During the month of October there were 42 calls for service, 35 were EMS related, 19 resulted in medical transport, 6 were fire alarm related, and our average response time was 9 minutes 5 seconds. These stats are returning to pre-pandemic ranges. We will work on shortening the response times. The service contract is not ready yet. At this time, I would like to take time to thank GM Napeahi for his time and effort with coming to terms to our agreement. At this time Marysville Fire District is seeing a reduction in COVID related calls for service. President Sheldon thanks Chief McFalls for his service.

Tulalip Police Department Monthly Report:

- Motion made to adopt Resolution 2021-42 approving the one (1) year Tulalip Tribes Prosecutorial Services Agreement with the Consolidated Borough of Quil Ceda Village for the 2022 calendar year in the amount of \$236,928 with funding to come from the 2022 QCV Public Safety Budget.
- Motion made to adopt Resolution 2021-43 approving the one (1) year Tulalip Tribes Attorney Services Agreement with the Consolidated Borough of Quil Ceda Village for the 2022 calendar year in the amount of \$179,770 with funding to come from the 2022 QCV Public Safety Budget.

Administration

- During the summer months, the QCV Public Health Inspector discovered there was sewage back up in one of the food vendors inside Seattle Premium Outlets. The vendor did not close their operations for decontamination because there was nothing in our policy requiring a closure. We would like this policy approved, so our inspector has sufficient justification for closures if this should occur again in the future.
- Motion made to adopt Resolution 2021-44 approving the Imminent Health Hazard Event Policy for the Tulalip community and general public effective immediately

Finance

- The Finance report is straightforward and on pace for the year, with the Hotel and Occupancy tax slightly down. The MBR project is near completion and the capital expenditures are on budget.
- Motion made to adopt Resolution 2021-45 approving the ratification of the 2021 Marine Drive Chevron

Budget increase of \$2,350,000 for Sales and increase of \$2,204,600 for Cost of Goods Sold and Expenses related to sales for the Marine Drive Chevron. The increase will be funded by increased Marine Drive Chevron revenue. No additional funds are being requested.

- Motion made to adopt Resolution 2021-46 approving the ratification of the 2021 Tulalip Liquor Store Budget increase of \$1,379,623 for Revenue and increase of \$1,379,623 for Expenses related to sales for the Tulalip Liquor Store. The increase will be funded by increased Tulalip Liquor Store revenue. No additional funds are being requested.
- Motion made to adopt Resolution 2021-47 approving the ratification of the 2021 Tulalip Market Budget increase of \$1,508,199 for Revenue and an increase of \$1,498,799 for Expenses related to sales for the Tulalip Market. This increase will be funded by Tulalip Market Revenue. No additional funds are being requested.

Human Resources

- Motion made to adopt Resolution 2021-48 approving the Retirement Severance Pay for Brian Rowland for 10 years, 3 months, and 17 days of service to Quil Ceda Village. Thank you, Brian!

Utilities

- Motion made to adopt Resolution 2021-49 approving the contract with Parametrix in the amount not to exceed \$115,838 to conduct and deliver a study of Ebey Slough Estuary for an effluent discharge for the Quil Ceda Village wastewater treatment plant with funding to come from Quil Ceda Village Utilities Capital Improvement funds.

Property Management

- Motion made to adopt Resolution 2021-50 approving the First Amendment to the Commercial Lease Agreement dated November 10, 2020 between Salish Sky Vapor and The Tulalip Tribes as presented.

DECEMBER 2021

Public Safety & Justice

Marysville Fire District Monthly Report:

- In November, Marysville Fire District responded to 47 calls for service 38 were EMS related, 4 resulted in transports, and 10 needed advanced life support. The average response time was better than the month before ranging between 7 and 8 minutes, rather than 8 to 9 minutes. Chief McFalls states that he would like to express his sincere

thanks to GM Napeahi and the Board for authorizing the service agreement for 2022. It is a privilege to continue to serve your community. Marysville Fire District ordered a new ladder and it is expected to be delivered in 600 days.

Tulalip Police Department Monthly Report:

- The monthly stats show that there was nearly a fifty percent drop in theft, average totals for crimes against people. The department did contract with Walmart and SPO (Seattle Premium Outlets) to have extra law enforcement onsite.
- Motion made to adopt Resolution 2021-51 approving the one (1) year Marysville Fire District Service Agreement with the Consolidated Borough of Quil Ceda Village for the 2022 calendar year in the amount of \$634,284.56 with funding to come from the 2022 QCV Public Safety Budget.

Finance

- The finance report shows that for the year our income is at roughly 92%, with the final payments made to the Public Safety. We have yet to receive the government payment of 400 hundred thousand for the land taxes collected in QCV.
- Motion made by Councilwoman Contraro to adopt Resolution 2021-52 approving the 2022 Quil Ceda Village Operating and Capital Expenditures Budget as presented.

Human Resources

- There have been some language corrections to the handbook, the Bereavement Leave has been updated, Juneteenth and Indigenous People's Day have been added to the Paid Holidays section, we have also added the Holiday Closure into the Handbook, so we will no longer need to bring a resolution forward to approve those days off. President Sheldon asked if there are any other changes. HR Manager Horne replied No, and further stated that these changes are consistent with Tulalip Tribes, future handbook changes will be done bi-annually.
- Motion made to adopt Resolution 2021-53 approving the Quil Ceda Village Employee Handbook amendments as presented, to be effective January 1, 2022.

Tulalip Data Services

- Motion made to ratify Resolution 2021- 54 approving a renewed 3-year agreement for CylancePROTECT endpoint threat prevention software in the amount of \$111,917 with funding to come from the 2021 TDS Budget.
- Motion made to adopt Resolution 2021- 55 approving the Microsoft Enterprise Licensing payment for 2022 for the Tulalip Tribes of Washington and Quil Ceda Village in the amount of \$428,785.83 with funding to come from the 2022 TDS Budget.

Property Management

- Motion made to adopt Resolution 2021- 56 approving the Fifth Amendment to amend and restate easements with covenants and restrictions affecting land between the Tulalip Tribes and Wal-Mart Real Estate Business Trust and Home Depot U.S.A., Inc.

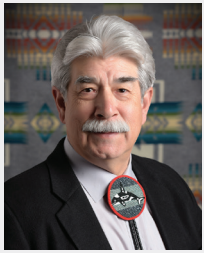

- Motion made to adopt resolution 2022-03 approving to authorize the execution and delivery of the agreement between the Consolidated Borough of Quil Ceda Village and Moss Adams in the amount of \$3,600 plus expenses for the 2021 Cigarette Tax audit.
- Motion made to adopt resolution 2022-04 approving to authorize the execution and delivery of the agreement between the Consolidated Borough of Quil Ceda Village and Moss Adams in the amount of \$3,600 plus expenses for the 2021 Fuel Tax audit.

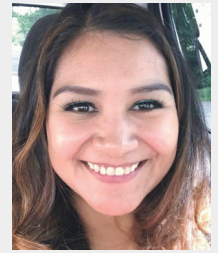
